The present translation was completed on the basis of the relevant German source text, however, the latter alone is legally authoritative.

HULL INSURANCE

The all risk coverage based on our Yacht Hull Clauses (YKB) gives you fair and comprehensive insurance coverage within your cruising area, as well as on land, in winter storage, whilst slipping and transporting your vehicle as well.

The sum insured is the price listed as new, also for new jet skis. Insured is the jet ski itself, the engine as well as the permanently installed nautical equipment. Partial damages will be settled with the price as new, repair costs will be settled to the full amount without any deduction „new for old“. In case of a total loss it will be settled with the current time value.

If the costs of repair will exceed the current time value of the jet ski the difference between the residual value and the current time value will be settled. When out the water the jet ski has to be secured with an immobilizer to protect it against unauthorized use. The jet ski is only insured outside the water if stored in closed rooms, on guarded parking lots, on enclosed and inhabited lots well fenced in on all sides. In case of storing the jet ski on a trailer the jet ski has to be fastened securely with a lock onto the trailer, and the trailer has to be secured by a wheel klaw, a lock or another equivalent security lock to prevent theft. During daytime on the beach, the jet ski has to be under constant supervision.

Not insured are damages occurring during races or regattas. The deductible per damage is 20 % of the overall damage sum, at least EUR 1.000,00.

LIABILITY INSURANCE:

Our liability insurance covers in the range of the contract damages to third parties caused by the use of the jet ski, including financial loss and damage to rented property. The maximum lump sum insured is EUR 3.000.000,00 for personal- and/or damage to property.

SCOPE OF INSURANCE

European inland and coastal waters including transport within Europe.
